

Corporate Sustainability Workshops for KPS and its Subsidiary Companies

16 July 2020: Employees who form the Corporate Sustainability Champion ("CSC") committee started trickling into the conference room early morning, perhaps with some feeling of uncertainty. It was the first gathering of some 20 employees during the Recovery Movement Control Order ("RMCO") period and another was perhaps mixed feelings towards the subject matter of Corporate Sustainability.

The programme was organised by the IRSC department. Puan Suzila Khairuddin, Deputy Chief Executive Officer (Finance & Corporate Services) opened the session with a welcome address and introduced Janice Monteiro-Lewis, CEO and Michael Lai, Senior Consultant from Monteiro Lewis Communications Sdn Bhd ("MLC") as well as their team who were facilitating the session.

This was the first programme spearheaded by the CSC in preparation for the Group's Sustainability Report for the financial year 2020.

Corporate Sustainability at its core, is about meeting the needs of the present without comprising the ability of future generations to meet theirs. The aim of the workshop was to deepen the participants' awareness about Corporate Sustainability and to guide them in creating long-term stakeholders' value through the implementation of a business strategy that focuses on the Economic, Environmental and Social ("EES") dimensions of doing business.

As it was important to cascade such business practices down to its wholly-owned subsidiaries, the workshops were subsequently conducted in Johor Bahru, at Century Bond Bhd ("CBB") on 24 August 2020 and Toyoplas Manufacturing (Malaysia) Sdn Bhd ("Toyoplas") on 25 August 2020. Participants from Taspack Industrial Sdn Bhd and CBB's Nilai office were also in attendance. In Penang, the workshop was held at CPI (Penang) Sdn Bhd ("CPI") on 1 September 2020.



During the workshops, the consultants urged the participants to share their thoughts and ideas through exercises that were specifically prepared. As much as possible, the objective was to create a comfortable and engaging atmosphere.

Detailed explanations on the concept of Corporate Sustainability, particularly on how to embed sustainability into business operations and corporate activities were emphasised. There were also in-depth

discussions about business directions and the integration of Corporate Sustainability in KPS, including measures to address considerations raised by the COVID-19 pandemic. It was important that the participants understand that effective management of the EES pillars require proper planning from the get-go, being proactive and ensuring action is taken. A lot of issues can be tackled by communicating and collaborating with one another rather than working in silos.

In improving the reporting regime, MLC presented the Interactive Cloud System digital platform, an initiative which digitalises data & information collation, collaboration and storage. This custom-built solution aims to simplify work processes, improves efficiency, reduces downtime, optimises employee productivity and frees up unnecessary data storage space. This platform acts as one-stop-centre for all matters about the Annual and Sustainability Reports.

Participants realised the importance of the buy-in of every individual within the organisation and how their roles and responsibilities translate into realistically achieving the Group's sustainability goals.

They were also made to see those good habits and practices contribute to better outcomes. The workshops also allowed participants to share their thoughts on how to overcome challenges, individually and collectively as well as their experiences, in both their personal and work lives during the lockdown period.

John Oo, a Senior Executive from CPI said "this year's Sustainability workshop is an improvement from the previous year as there were more in-depth coverage and examples were given to us for a better understanding of the subject matter."

version of ourselves. The pandemic has affected us so much so that it would be ashamed if we did not find a creative way forward to win the battle. We have the freedom now to do something different than before.


Otherwise, all that the pandemic will leave us with is just a sad painting.

September 2020: KPS held its second-quarter 2020 results Lifting via an online platform, keeping the analysts and fund managers apprised of the Group's business updates and prospects.

COVID-19 has put a damper on the performance of KPS' manufacturing business which saw a decline in capacity utilisation of its packaging, plastic injection moulding and mattress manufacturing plants. Despite reporting a 39% yearon-year growth in revenue to RM221.5 million for the quarter ended 30 June 2020, the Group recorded an operating loss of RM1.6 million on heavy expenses, subsequently registering RM11.4 million Loss Attributable to the Owners of the Parent.

With the permeating impact of the pandemic expected to continue, KPS is cautious of its business outlook. However, the Group is determined to improve its business prospect by focussing on improvement in operational efficiency, stabilising the supply chain and creating new demand. These efforts will see KPS penetrate new market segments and expand product offerings, putting the Group on a stronger footing in bridging recovery and regaining business momentum.







ENVIRONMENTAL

Waste Management Training Programmes for KPS' Manufacturing Arm

21 September 2020: In recent years, the government has been focussing on encouraging companies to reduce industrial waste generated from manufacturing activities and to manage waste effectively. Responding to the call, while at the same time executing KPS' sustainability mission, the IRSC department organised Waste Management Training Programmes for KPS' manufacturing subsidiaries.

The trainings took place at Toyoplas, CBB and CPI on 21, 22 and 29 September 2020 respectively, and were conducted by Dr Theng Lee Chong, a Waste Management expert from SoluWaste Management Consultants.

The purpose of the training sessions was to expose participants on all facets of waste management which includes municipal solid wastes and scheduled wastes. In particular, new laws and regulations were emphasised, enforcements in the context of the manufacturing sector and for the participants to gain insights onto the government's current incentives. This was also an ideal platform for the employees concerned to address issues and challenges with regards to waste management.

Managing waste through recycle, reduce and reuse of manufacturing materials are the key to achieve success in waste reduction efforts, as highlighted by Dr Theng. After the informative sessions and site visits at every company, the management team and Dr Theng engaged in in-depth discussions on their existing waste management potential and problems. Dr Theng provided recommendations on practical solutions for execution to ensure compliance with the local authority as well as managing waste efficiently. It has also paved the way for the subsidiaries to seek further advice and guidance in improving their waste management efforts.








KPS CerDik Programme

The CerDik 2020 Programme that was affected by the imposition of the Movement Control Order ("MCO") resumed on 22 and 23 July at SK(A) Bukit Cheding and SK(A) Bukit Kemandol respectively after obtaining the permission from the Selangor State Education Department on 6 July 2020. The final session for SK(A) Bukit Kemandol was delivered on 1 October, whilst session for SK(A) Bukit Cheding will be delivered on 7 October 2020.

Due to the MCO and the cancellation of UPSR examination this year which disrupted the study momentum for the students at SK(A) Bukit Cheding. However, the programme was able to realign the students' interest including their mindset to ensure that the overall objective of keeping them in school is still achievable. Further discussions with the respective school's principal and teachers involved, have also indicated that this programme has provided the necessary support as well as complements the efforts by the teachers in instilling a positive mindset amongst the students.

Following the completion of the programme, 94% of the participants are employed to the Home Care industry while the remaining are venturing into starting their own caregiving services business.

KPS Lifeguarding And Swimming Instructor Certification Course

PS in collaboration with Supersharkz Sdn Bhd Kimplemented lifeguarding and swimming instructor certification course for juvenile delinquents. The objective of the programme was to equip them with the required soft skills and technical skills as well as providing them with an opportunity to upskill themselves whilst gaining some valuable work experience that they are in dire need of. The programme provided:

- A new and fresh start to their lives ٠
- Opening a job opportunity for them ٠
- Getting and learn a new set of skill ٠
- Certification on the skill learned
- Bring positive transition into their life ٠

The course started from 13 to 30 July 2020. Four juveniles from Sungai Buloh Correctional Centre participated in the course. Under this programme, three participants were assigned for non-administrative tasks whilst one participant was assigned to undertake administrative support for the centre.

The forth juvenile was assigned to undertake Administration duties, to provide essential administrative support to the executives and other departments. Under this role, he was responsible to assist both complex and general administrative duties, allowing their supervisors to carry out their managerial tasks.

SAFETY & HEALTH

Basic Occupational **First Aid** Training Programme







23 and 24 September 2020, KPS organised a two-day Basic Occupational First Aid, Cardiopulmonary Resuscitation ("CPR") and Automated External Defibrillator ("AED") Training Programme for the selected first aiders consisting KPS employees and Plaza Perangsang tenants.

16 participants were trained by the Malaysian Red Crescent Society on the basic life support skills such as CPR and Heimlich Manoeuvre, a method to treat choking, and other first-aid related topics such as bleeding and wounds, burn and scald, fracture and spinal injuries. The programme consists of theory presentation, practical session, and life-like simulation, upskilling the participants with not only the knowledge but also the skills to handle various emergencies.

The training programme was a KPS' initiative to ensure a practicable workplace, safety and health of its stakeholders. It was also in compliance with the requirements under Section 15(2)(C) of the Occupational Safety and Health Act 1994 (Act 514).


Signing Ceremony between KPS and **Training Providers**
