## 2Q21 RESULT BRIEFING



**3 September**: KPS held its second-quarter 2021 results briefing today via an online meeting platform, keeping the analysts and fund managers apprised of the Group's business performance, operations, as well as its near-term prospect. The Group registered resilient topline, but supply chain challenges persistent, casting shadow on KPS' 2Q21 core earnings.

- Revenue grew 46% to RM323.8 million;
  - Operating profit leapt to RM15.9 million from a loss position;
- and Profit Attributable to Owners of the Parent of RM1.6 million, compared to a loss of RM11.4 million it posted in the corresponding quarter last year.
